#### Organizing import and Limitation of some Electric Appliances and Materials

Emanating from keeping up the country wealth in terms of energy and clear environment in line with Qatar Vision 2030, Laboratories & Gauges Affairs within the Ministry of Environment promulgates start of organizing import and limitation of some electric appliances and materials in association with the Ministry of Energy and Industry KAHRAMAA and Ministry of Economy and Commerce as following:

### First: Energy saving Air -conditioners (Window and Split) only

- 1. Allow to import energy saving air-conditioners (windows and split) only in conformity with appeared Qatari specification No. 2663
- 2. Rate of power efficiency of above air conditioners shall not fall below 8.5 British thermal units/hour EER=8.5 Btn/hr as per inspection circumstances (T1) for all said air-conditioners.
- 3. Provision of an original certificate from an accredited laboratory with ISO 17025 confirming that specification of said air-conditioners are in compliance with said conditions and standards of Qatar standard specification No. 2663

#### Second: Tungsten Lamps

- 1. Restrict import of **Tungsten** lamps due to their negative impact on power consumption and environment. Restriction shall be first stage for following brands: lamps of 75 & 100 watts.
- 2. Allow importation of energy saving lamps provided that same shall be enclosed with an original certificate for plant confirming the same in conformity with accredited Oatar standard specifications

Please note that said procedures in this advertisement will be implemented with effect from 1/1/2014. Hence laboratories and Gauges affairs with the Ministry of Environment urge all traders and importers to comply with procedures for public interest
